

Enchant Christmas Sweepstakes

Official Rules

1. NO PURCHASE OR PAYMENT IS NECESSARY TO ENTER. The Enchant Sweepstakes (the "Sweepstakes") is open to legal residents physically residing in the Texas State who are 18 years of age or older as of date of entry. Void wherever prohibited by law. Sweepstakes begins 12:01AM CST November 24, 2017 and ends December 31, 2017 at 11:59pm CTS (the "Term"). For purposes of these Official Rules, all times are Central Standard Time ("CST")

3. CHANGE OF ADDRESS POLICY: It is the sole responsibility of the entrant to notify Sponsor if the entrant changes his or her mailing or e-mail address.
